6.2 Strategic Plan Update

D. Peschel: we should focus on stormwater, as it's the most important thing that we can do to retain ecological function of the coastal watershed. We could create a wastewater ordinance for the higher, smaller towns in the watershed. As communities that don't have water systems



expand, communities with wastewater systems and drinking water can expand to meet long-term needs.

S. Frost: We need to facilitate the municipalities' interests, at least hold a meeting to address Portsmouth's interest in the economic impacts of sharing or not sharing a stormwater utility with other towns.

Could SWA get a grant from the EPA to do a feasibility analysis to see if the utility makes sense. Then approach 3-4 towns to participate. If grant money is available, SWA could facilitate it. M. Trainque: DES approved a \$240,000 SRF loan to SWA but we need ideas about how to do it.

- D. Cedarholm: The strategic plan is missing a plan that has a strategy to strengthen SWA's membership.
- W. Arcieri: We should maximize our visibility, and have enough funding for administrative assistance, that we can't contribute enough as volunteers.
- G. Rief: We should include the Maine towns in the watershed, including them in our emails. C. Albert: Linda Shire is very active in that area.

BOD members agreed that a workshop is needed for the strategic plan. The workshop should address include a solid financial plan. Workshop to take place at HTA 4:30 - 7:30 p.m. May 17, 2017.
